

APPLICATION FOR OAA ARTIST MEMBERSHIP

The Ogunquit Art Association, established in 1928 as an organization of professional artists, is accepting applicants for membership in the categories of painting, graphics, sculpture, and photography.

Applicants must live in the State of Maine or within a 100-mile radius of Ogunquit for two weeks of every year, with one year's exception permitted. Sculptors may live in any one of the six New England states or spend two weeks of every year within a 100-mile radius of Ogunquit. The OAA is a cooperative group and relies on the active participation of its members. Members may exhibit work only in the categories in which they have been accepted.

Jurying and Membership are under the jurisdiction of the OAA Board of Directors. A panel of five jurors, elected by the OAA membership, will review applicants' digital images and make recommendations for OAA membership.

Here's the process:

Painters, graphic artists, photographers, and sculptors must enter ten .jpeg images. Email to: oacbarngallery@gmail.com An Application/Bio may also be emailed or may be mailed to Ogunquit Art Association, P O Box 794, Ogunquit ME 03907.

Jpegs of artwork should be 72 dpi and 1920 pixels on the long side. Please label artwork: #1_artist_title, #2_artist_title, #3_artist_title, etc. [Add medium and size on separate list.]

You may need to send several emails for 10 jpegs and entry/bio material.

Subject line for each email should read – OAA Jury – Artist Name - # - # or Artist Name - entry/bio

Applications, bios and images via email must be received by **5 PM ,Monday, June 7, 2021.**

Following the Jury's review of Applications, the Jury will invite selected artists to enter three actual works for the second screening. Sculptors may enter multiple jpeg images of these 3 pieces for the second screening if unable to show actual work. Jpeg images must be properly labeled (see above). Works are to be brought to the Barn Gallery at the corner of Shore Road & Bourne Lane, Ogunquit at a time to be determined.

The Jury will make their final decision after seeing actual work.

All artists must pick up their work at a time to be determined.

Applicants will be informed of the jury's decision by email or by mail. Please note that the jury process is only for screening rather than critiquing prospective members. There is no charge for participating in the jury process and artists who are not invited to join one year are encouraged to try again.

Artists who have been accepted for membership will receive information for Receiving for the next exhibitions and activities as well as the schedule for the rest of the season. They will also be asked to pay Annual Dues of \$95.00 and to volunteer to help at the gallery. [Volunteering is on hold during the pandemic.]
